Order

Sri A. Goutham, Mancherial District has filed a Complaint dated: 20-4-2022 which was received by this Commission on 21-04-2022 for not getting the information sought by him from the PIO / O/o the Municipal Commissioner, Naspur Municipality, Mancherial District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: 08-02-2022 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application annexed.

Stating that the PIO has not furnished the required information even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, the Complaint was taken on file and Notices issued to both the parties for hearing on 21-07-2022 at 12.00 P.M.

The case is called on 21-07-2022. The complainant is absent. The PIO / O/o the Municipal Commissioner, Naspur Municipality, Mancherial District is also absent.

Perused the material papers available on record and observed that the complainant filed 6(1) application dated: 08-02-2022 seeking certain information and the PIO vide letter No: G1/23/RTI/2022 dated: 07-03-2022 furnished the information to the complainant and the same was acknowledged by the complainant on 03-08-2022. The complainant filed complaint dated: 20-04-2022 u/s 18(1) of RTI Act 2005 stating that the PIO has furnished incomplete information, but failed to submit as to which point / part of the information furnished is incomplete.

The Commission took a serious view against the PIO for not appearing before the Commission for the hearing held on 21-07-2022 and warns the PIO not to repeat such lapses in future and strictly adhere to the provisions of the RTI Act 2005.

The Commission directs the PIO to furnish the information once again (Keeping in view of Section 8, 9, 10 & 11 of the RTI Act 2005) to the complainant duly attesting within One (1) Week from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the complaint is closed.
