## Order

Sri T. Ramachandra Reddy, Hayathnagar, Ranga Reddy District has filed a Complaint dated: 23-04-2022 which was received by this Commission on 25-04-2022 for not getting the information sought by him from the PIO / O/o the Depot Manager, TSRTC, Hayatnagar Depot, Rangareddy District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: 14-03-2022 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application annexed.

- ① Muster copies (Manual) from 17/2/21 TO Till date
- ② Copies of Leave memos Granted from 17/2/21 TO Till date
- ③ Copies of Leave memos Rejected from 17/2/21 TO Till date
- ④ Copies of TI Drivers from 17/2/21 TO Till date
- ⑤ List of absent employees from 17/2/21 TO Till date.
- ⑥ List of employees Suspended, Removal and Transferred (Muster Part) along with enquiry copies. 17/2/21, To Till date
- ⑦ List of Drivers attended MADARAM JATHARA (Attended & Absent)
- ⑧ Action taken report on crew not reporting (absent) to 'MADARAM JATHARA'
- ⑨ S R copies of Hire Spl (operated) of only GARUDA PLUS along with N.R. copies.
- ⑩ Copies of Out going & in coming of Vehicle report of VIG & Security report from 16/2/22 TO Till date

Stating that the PIO has not furnished the required information even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, the Complaint was taken on file and Notices issued to both the parties for hearing on 01-09-2022 at 10.30 A.M.

The case is called on 01-09-2022. The complainant is present and filed his affidavit stating that the PIO has not furnished the information. The APIO / Sri G. Shambaiah, Superintendent (P), HYT – 2, O/o the Depot Manager, TSRTC Hayatnagar Depot, Ranga Reddy District is present and filed his affidavit stating that reply was given to the complainant vide letter No: Supdt(P)/RTI(1)/2022-HYT-II dated: 08-04-2022 informing that the information sought is of 3<sup>rd</sup> party and the same could not be furnished as per Section 8(1)(j) of RTI Act 2005 and filed copy of the letter along with the postal receipt before the Commission.

Heard both the parties and perused the material papers available on record.

The Commission directs the PIO to furnish the information (Keeping in view of Section 8, 9, 10 & 11 of the RTI Act 2005) to the complainant within One (1) Week from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the complaint is closed.
