Order

Smt. N. Laxmamma, Nalgonda District has filed 2nd appeal dated: 25-04-2022 which was received by this Commission on 26-04-2022 for not getting the information sought by her from the PIO / O/o the Tahsildar, Kondamallepalli Village & Mandal, Nalgonda District and 1st Appellate Authority / O/o the District Collector, Nalgonda Collectorate, Nalgonda District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 25-02-2022 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in her application:

1. పై సర్వే నెంబర్లలో మొత్తం విస్తీర్ణం ఎంత, 1954-55 ఖాసా పహాణి అనుసరించి అట్టి సర్వే నెంబర్లలో మొత్తం విస్తీర్ణంను 3 సమాన భాగాలుగా ముగ్గురికి అట్టి భూమి కేటాయించినట్లు నమోదు అయిన ఉంది. కావున అట్టి ముగ్గురి పేరున ఎంత విస్తీర్ణం ఒక్కొక్కరికి కేటాయించారనేది రికార్డుల అనుసరించి సమాచారం ఇవ్వగలరు.
2. ఒక్కొక్క భాగాన్ని ఎంత విస్తీర్ణం ఏ సర్వే నెంబర్లు కేటాయించారు.
3. పై మూడు భాగాల్లో మా నాన్న గారు బోడ సాయిలు @ సాయన్న తండ్రి బుచ్చయ్యకు సంబంధించిన భాగ కేటాయింపు ఏ సర్వే నెంబర్లలో ఎంత కేటాయించారు, తదనంతరం ఆయన నుండి ఆ విస్తీర్ణం ఎవరెవరికి బదలాయించబడిందో అట్టి మార్పుల రిజిస్టర్ సర్టిఫైడ్ కాపీలు ఇవ్వగలరు.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 25-03-2022 before the 1st Appellate Authority requesting him to furnish the information sought by her u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, she preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by her and also to arrange to furnish the information sought by her u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal was taken on file and Notices issued to both the parties for hearing on 02-09-2022 at 10.30 A.M.

The case is called on 02-09-2022. The appellant is absent. The PIO / Sri K. Chandra Shekhar, Deputy Tahsildar, Kondamallepalli Mandal, Nalgonda District is present and filed his affidavit stating that reply was given to the appellant vide letter No: B/341/2022 dated: 11-05-2022 informing that the information is in questionnaire form, hence the same could not furnished.

Sri D. Sunil Kumar, Senior Assistant is present and filed affidavit of the PIO / Sri A. Bhaskar Rao, District Revenue Officer (FAC), O/o the District Collector, Nalgonda District stating that vide letter No: A5/2436/2022 dated: 18-03-2022 the application was forwarded u/s 6(3) of the RTI Act to the PIO / O/o the Tahsildar, Kondamallepalli Mandal, Nalgonda District with a request to furnish the information to the appellant.

Heard the PIO and perused the material papers available on record. The PIO submitted that on receipt of the Commission notice dated: 22-08-2022 the information was furnished to the appellant on 11-08-2022. The Commission is of the view that the PIO has furnished the information to the appellant.

Since the information is furnished, the appeal is closed.
