Order

Sri M. Rama Krishna, Nizamabad District has filed 2nd appeal dated: 25-04-2022 which was received by this Commission on 11-02-2022 for not getting the information sought by him from the PIO / O/o the Tahsildar, Indalwai Mandal, Nizamabad District and 1st Appellate Authority / O/o the Revenue Divisional Officer, Nizamabad Division, Nizamabad District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 01-02-2022 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

The PIO vide Lr. No. B/4/2019, dated. 08-02-2022 furnished the information to the appellant.

Aggrieved with the reply from the PIO, the appellant filed 1st appeal dated: 11-02-2022 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal was taken on file and Notices issued to both the parties for hearing on 15-09-2022 at 10.30 A.M.

The case is called on 15-09-2022. The appellant is present and filed his affidavit stating that the PIO has not furnished the information. The PIO / Smt. B. Vijaya, Deputy Tahsildar, Indalwai Mandal, Nizambad District stating that reply was given to the appellant vide letter No: B/4/2019 dated: 08-02-2022 informing to specify which type of the information the appellant wants to verify. The PIO filed copy of the letter along with postal receipt before the Commission.

Sri S. Srinivas, Divisional Administrative Officer is present on behalf of the First Appellate Authority / Sri T. Ravi, Revenue Divisional Officer, Nizambad Division & District and filed his affidavit stating that vide letter No: A4/966/2022 dated: 04-03-2022 the appellant and the PIO were called for hearing on 11-03-2022 and since the appellant was absent another date was fixed on 21-03-2022 for hearing, but during the hearing the appellant could not specify which part of the information the appellant wants to verify.

Heard both the parties and perused the material papers available on record. Upholding the version of the PIO and the First Appellate Authority, the Commission advises the appellant to file a separate 6(1) application seeking specific information so as to enable the PIO to furnish the same.

In view of the above, the appeal is closed.
