Order

Sri B. Srinivas Reddy, Narayanpet District has filed 2nd appeal dated: 29-04-2022 which was received by this Commission on 02-05-2022 for not getting the information sought by him from the PIO / O/o the District Collector, Narayanpet Collectorate, Narayanpet District and 1st Appellate Authority / O/o the District Collector, Narayanpet Collectorate, Narayanpet District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 19-03-2022 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

POINT 1 మా WRITTEN COMPLAINT పై విచారణ గౌరవ అధికారులు చేసుకున్నారు. తెలుపవలసినదిగా అభ్యర్థించడమైనది.

POINT 2 WRITTEN COMPLAINT ప్రస్తుతం విదేశాల ఉన్నది. తెలుపగలరని PIO నారికి అభ్యర్థన చేయనైవది. దీనికి సంబంధించిన (విదేశాల ఉన్నది) జాబితాలు ఇవ్వండి.

POINT 3 మా WRITTEN COMPLAINT పై సమాగ్ర విచారణ నివేదనను అందజేయగలరు అని మనవి.

POINT 4 మా WRITTEN COMPLAINT ను పాపరంతులు జాప్యం చేసి కారణాలు మాయా బుద్ధులు అను అధికారులు ఎవరు తెలయ చేయండి.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 19-03-2022 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal was taken on file and Notices issued to both the parties for hearing on 15-09-2022 at 12.00 P.M.

The case is called on 15-09-2022. The appellant is present and filed his affidavit stating that the PIO has not furnished the information. The APIO / Sri C. Narsingh Rao, Administrative Officer, O/o the District Collector, Narayanpet District is present and filed his affidavit stating that reply was given to the appellant vide letter No: H3/162/2022 dated: 02-03-2022.

Heard both the parties and perused the material papers available on record. The appellant stated that the PIO has furnished wrong information. The Commission took a serious view against the PIO and warns the PIO not to repeat such lapses in future and strictly adhere to the provisions of the RTI Act 2005.

The Commission directs the PIO / O/o the District Collector, Narayanpet District and the PIO / Deputy Tahsildar, Narva Mandal, Narayanpet District to inform the action taken on the appellant's complaint dated: 12-10-2021 within One (1) Week from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the appeal is closed.
