Order

Sri Md. Jabeer, Adilabad District has filed 2nd appeal dated: 21-04-2022 which was received by this Commission on 02-05-2022 for not getting the information sought by him from the PIO / O/o the Tahsildar, Bela Mandal, Adilabad District and 1st Appellate Authority / O/o the Revenue Divisional Officer, Adilabad Division, Adilabad District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 04-01-2022 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

I am submitting here with my B.P.C. card's statement to provide the such information free of cost for my Jeeva P.D.O & C.P.D.C in India under R.T.I. Act - 2005

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 09-03-2022 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal was taken on file and Notices issued to both the parties for hearing on 15-09-2022 at 12.00 P.M.

The case is called on 15-09-2022. The appellant is present and filed his affidavit stating that the PIO has not furnished the information. The PIO / Sri S. Vaman Rao, Deputy Tahsildar, Bela Mandal, Adilabad District is present and filed his affidavit stating that reply was given to the appellant vide letter No: A/103/2022 dated: 22-02-2022 and filed copy of the same before the Commission.

Heard both the parties and perused the material papers available on record. The appellant stated that the PIO has furnished incomplete information, the PIO submitted that the available information is brought to the Commission and furnished the information to the appellant before the Commission under acknowledgement of the appellant.

Since the information is furnished, the complaint is closed.
