### Order

Sri M. Rama Krishna, Nizamabad District has filed 2<sup>nd</sup> appeal dated: 30-04-2022 which was received by this Commission on 05-05-2022 for not getting the information sought by him from the PIO / O/o the Tahsildar, Navipet Mandal, Nizamabad District and 1<sup>st</sup> Appellate Authority / O/o the Revenue Divisional Officer, Nizamabad Division, Nizamabad District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 21-02-2022 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

Stating that the appellant did not receive the information from the PIO, the appellant filed 1<sup>st</sup> appeal dated: 24-03-2022 before the 1<sup>st</sup> Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1<sup>st</sup> Appellate Authority even after 30 days of filing his 1<sup>st</sup> appeal, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to take action against the PIO and 1<sup>st</sup> Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2<sup>nd</sup> appeal was taken on file and Notices issued to both the parties for hearing on 15-09-2022 at 10.30 A.M.

The case is called on 15-09-2022. The appellant is present and filed his affidavit stating that the PIO has not furnished the information. The APIO / Sri B. Devi Singh, Senior Assistant, O/o the Tahsildar, Navipet Mandal, Nizambad District is present and filed his affidavit stating that reply was given to the appellant vide letter No: A/152/2022 dated: 08-03-2022 informing that the information sought is of 3<sup>rd</sup> party and without taking their consent as Section 11 of RTI Act 2005 the information could not be furnished. The APIO filed copy of reply along with the postal receipt before the Commission.

Sri S. Srinivas, Divisional Administrative Officer is present on behalf of the First Appellate Authority / Sri T. Ravi, Revenue Divisional Officer, Nizambad Division & District and filed his affidavit stating that vide letter No: A4/1329/2022 dated: 28-03-2022 the appellant and the PIO were called for hearing on 08-04-2022.

Heard both the parties and perused the material papers available on record. The Commission upholds the reply of the PIO.

In view of the above, the appeal is closed.
