Order

Sri Sukenapally Ramu, Karimnagar District has filed 2nd appeal dated: 29-04-2022 which was received by this Commission on 05-05-2022 for not getting the information sought by him from the PIO / O/o the Sub Division, MB Intra (RW&s), Huzarabad Office, Huzurabad Division, Karimnagar District and 1st Appellate Authority / O/o the Sub Division, MB Intra (RW&s), Huzarabad Office, Huzurabad Division, Karimnagar District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 17-02-2022 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

3. మి కార్యాలయం నుంచి 303,621,304,268,269,269 ఈ నెంబర్ కు సంబంధించిన 2020 సంవత్సరంలో ఎనులకు సంబంధించి MB రికార్డ్ చేస్తే దానికి సంబంధించిన ఎస్టిమేట్ కాఫీ లు మరియు తీర్మానం కాఫీ ఇవ్వగలరు.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 23-02-2022 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal was taken on file and Notices issued to both the parties for hearing on 26-09-2022 at 12.00 P.M.

The case is called on 26-09-2022. The appellant is absent. The PIO / Sri Khaja Vasiuddin Ahmed, Deputy Executive Engineer, O/o the Sub Division MB Intra (RW&s), Huzurabad Division, Karimnagar District is present and filed his affidavit stating that the available information was furnished to the appellant vide letter No: AEE/MBI/HZB dated: 24-09-2022 and filed copy of the covering letter before the Commission.

Heard the PIO and perused the material papers available on record. The PIO submitted that the remaining information would be available with the PIO / Gram Panchayat Secretary, Peddapapaiahpally Village, Huzurabad Mandal, Karimnagar District.

The Commission took a serious view against the PIO for not furnishing the information to the complainant within the stipulated period of 30 days as per Section 7(1) of the RTI Act 2005. The Commission warns the PIO not to repeat such lapses in future and strictly adhere to the provisions of the RTI Act 2005.

The Commission directs the PIO / Gram Panchayat Secretary, Peddapapaiahpally Village, Huzurabad Mandal, Karimnagar District to furnish the information to the appellant duly attesting within Two (2) Weeks from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the appeal is closed.
