Order

Sri A. Sai Raj, Jagtial District has filed 2nd appeal dated: Nil which was received by this Commission on 11-01-2022 for not getting the information sought by him from the PIO / Assistant Commissioner for Government Examinations, O/o the Director of Govt., Examinations, Chapal Road, Nampally, Hyderabad and 1st Appellate Authority / O/o the Director of Govt., Examinations, Chapal Road, Nampally, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 29-09-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

1) Please provide a photocopy of SSC Memo of

2) Please Provide Photocopy of ' X class Record Book ' and any other Record (i e, Information) held at Board of Secondary Education , Hyderabad containing the following Details (i) Register No (ii) Name (iii) Father Name (iv) Date of Birth (v) Year of Pass (vi) School (vii) Marks Details, of the
Register No: 276471
Name: Musku Kondal Reddy , Father Name: Musku Dasharath Reddy ,
Year of Exam: March 1983 , School: Zilla Parishad High school, Gollapalli.
District: Karimnagar (Jagtial) , Date of Birth: 02-01-1965 .

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 29-10-2021 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal was taken on file and Notices issued to both the parties for hearing on 26-09-2022 at 10.30 A.M.

The case is called on 26-09-2022. The appellant is present and filed his affidavit stating that the PIO has not furnished the information. The PIO / Smt. K. Soujanya, Assistant Commissioner, O/o the Director of Government Examinations, Chapal Road, Nampally, Hyderabad is present and filed her affidavit stating that reply was given to the appellant vide letter Rc. No: 01/PIO/Q4-1/2021 dated: 20-10-2021 informing that the information sought cannot be furnished since it is not related to him. The PIO filed copy of the same before the Commission.

Heard both the parties and perused the material papers available on record.

The Commission directs the PIO to inform the procedure for obtaining the required information to the appellant within One (1) Week from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the appeal is closed.
