Order

Sri R. Ram Babu, Nalgonda District has filed a Complaint dated: 05-05-2022 which was received by this Commission on 06-05-2022 for not getting the information sought by him from the PIO / O/o the Tahsildar, Adavidevlapalli Mandal, Nalgonda District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: 14-03-2022 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application annexed.

1) అడవిదేవులపల్లి మండలంలోని ముదమాణిక్యం గ్రామంలో సర్వే నెం.242/2అ/1 242/2అ/1, ఖాతా నెంబర్ 1062, రిజిస్ట్రేషన్ తేదీ : 28/12/2021 డాక్యుమెంట్ నెంబర్ 485/2021 యందు పాతులోతు రామ్ సింగ్ S/o రఘు (లేట్) గారికి ఎకరం 01-03 గుంటల భూమి రెవెన్యూ రికార్డు కలదు. అట్టి ఎకరం 01-03 గుంటల భూమి రెవెన్యూ రికార్డు నుండి తొలగించినారు. అట్టి పట్టా భూమి రికార్డుని ఎవ్వరి పేరు మీద నమోదు చేసినారు.

2) అట్టి పట్టా రికార్డు ప్రస్తుత పట్టాదారునకు ఏవిధముగా సంక్రమించినది, అట్టి డాక్యుమెంట్ నిజ ప్రతులు ఇవ్వగలరు.

Stating that the PIO has not furnished the required information even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, the Complaint was taken on file and Notices issued to both the parties for hearing on 02-09-2022 at 10.30 A.M.

The case is called on 02-09-2022. The complainant is absent. The APIO / Sri G. Koteswar, Senior Assistant is present and filed affidavit of the PIO / Sri G. Saidulu, Tahsildar (I/c), Adavidevulapalli Mandal, Nalgonda District stating that vide letter No: A/234/2022 dated: 17-03-2022 as per Section 11 of RTI Act 2005 a letter was addressed the concerned party with a request to give their consent and on 24-03-2022 the 3rd party refused to furnish the information as per section 8(1)(j) of RTI Act and the same was informed to the complainant vide letter No: 01-04-2022. The PIO filed copy of the letter before the Commission.

Heard the PIO and perused the material papers available on record.

The Commission directs the PIO to furnish the available information to the complainant duly attesting within One (1) Week from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the complaint is closed.
