## Order

Sri S. Anjaiah, Nalgonda District has filed 2<sup>nd</sup> appeal dated: 05-05-2022 which was received by this Commission on 06-05-2022 for not getting the information sought by him from the PIO / O/o the Tahsildar, Dhamacharla Village & Mandal, Nalgonda District and 1<sup>st</sup> Appellate Authority / O/o the Revenue Divisional Officer, Miryalguda Division, Nalgonda District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 19-05-2020 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

2) యి సేవల ఏడాది 3) అట్టి యేటి ప్రాధికారాలు

Stating that the appellant did not receive the information from the PIO, the appellant filed 1<sup>st</sup> appeal dated: 11-07-2020 before the 1<sup>st</sup> Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1<sup>st</sup> Appellate Authority even after 30 days of filing his 1<sup>st</sup> appeal, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to take action against the PIO and 1<sup>st</sup> Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2<sup>nd</sup> appeal was taken on file and Notices issued to both the parties for hearing on 02-09-2022 at 10.30 A.M.

The case is called on 02-09-2022. The appellant is present and filed his affidavit stating that the PIO has not furnished the information. The APIO / Sri D. Sateesh, Girdhawar is present and filed affidavit of the PIO / Sri Md. Abdul Khadar, Deputy Tahsildar, Damacharla Mandal, Nalgonda District stating that vide letter No: A/341/2020 dated: 30-05-2020 the appellant was requested to pay Rs. 3578/- and obtain the required information, since the appellant did not pay the requisite fee the same was not furnished. The APIO filed copy of the same before the Commission.

Sri Md. Hasimullah Sharif, Deputy Tahsildar is present and filed affidavit of Sri. B. Rohith Singh, Revenue Divisional Officer, Miryalguda Division, Nalgonda District stating that vide letter No: H/2624/2020 dated: 13-08-2020 the appellant and the PIO were called for hearing on 25-08-2020 and directed the PIO to furnish the information to the appellant within One week.

Heard both the parties and perused the material papers available on record.

The Commission directs the PIO to allow the appellant for verification of records on a mutually fixed date and time by giving a prior intimation to the appellant and furnish the required information after paying the requisite fee as per RTI Act 2005 through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the appeal is closed.
