Order

Sri V. Bapurao, Adilabad District has filed 2nd appeal dated: 03-05-2022 which was received by this Commission on 06-05-2022 for not getting the information sought by him from the PIO / Assistant Secretary to Government, School Education (Vigilance) Department, Telangana Secretariat, BRKR Bhavan, Hyderabad and 1st Appellate Authority / Deputy Secretary to Government, School Education (Vigilance) Department, Telangana Secretariat, BRKR Bhavan, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 03-03-2022 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

I submit that the School Education Vigilance Depart Govt of Telangana Hyderabad has informed through the reference first & IInd cited and arranged a copy of Govt. Memo No.7186/vig.I(2) dt.16.3.2021 on appeal filed under RTI Act 2005 dt.3.4,2021duly requesting the Director of School Education to furnish report as called in said Govt.Memo..

Hence I am filed appeal under 2(J) RTI Act 2005 kindly to arrange a copy of which kind of information submitted by the Director of school Education TS Hyderabad in response to the said Govt.Memo dt 16.3.2021 as per section 7(1),6 (1) RTI Act 2005 along with a copy of Memo No.7186/Vig.I(2)2009 – 34 dt.15.05.2015 during the tenure of Hon,ble Principal Secretary Rajeswar Tiwari

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 04-04-2022 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal was taken on file and Notices issued to both the parties for hearing on 26-09-2022 at 10.30 A.M.

The case is called on 26-09-2022. The appellant is absent. The PIO / Sri S. Sreenivas, Assistant Secretary to Government, School Education (Vigilance) Department, Telangana State Secretariat, BRKR Bhavan, Hyderabad is present and filed his affidavit stating that reply was given to the appellant vide letter No: 2564/SE-Vig/A2/2022 dated: 29-03-2022 informing that the information sought come under purview of Section 8(1)(h) of the RTI Act 2005. The PIO filed copy of the letter before the Commission.

Heard the PIO and perused the material papers available on record.

The Commission upholds the reply of the PIO and the First Appellate Authority, hence the appeal is closed.
