Order

Sri V. Venkata Ranga Reddy, Mahabubnagar District has filed 2nd appeal dated: Nil which was received by this Commission on 09-05-2022 for not getting the information sought by him from the PIO / O/o the Tahsildar, Rajapur Mandal, Mahabubnagar District and 1st Appellate Authority / O/o the District Collector, Mahabubnagar Collectorate, Mahabubnagar District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 01-11-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 02-12-2021 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal was taken on file and Notices issued to both the parties for hearing on 01-09-2022 at 12.00 P.M.

The case is called on 01-09-2022. The appellant is present and filed his affidavit stating that the PIO has not furnished the information. The PIO / Sri M. Bharat Kumar, Deputy Tahsildar, Rajapur Mandal, Mahabubnagar District is present and filed his affidavit stating that reply was given to the appellant vide letter No: B/RTI/396/2022 dated: 21-04-2022. The PIO filed copy of the reply before the Commission.

Heard both the parties and perused the material papers available on record. The appellant stated that PIO has not furnished the copy of the file No: A9/4895/82 of Sy. No: 548. The PIO submitted that the file is not available incase the appellant can provide the copy of faisal patti the same may be searched and furnished.

The Commission directs the PIO to make a through search or give a specific reply to the appellant duly attesting within One (1) Week from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the appeal is closed.
