Order

Sri K. Sanjeev Goud, Nirmal District has filed a Complaint dated 23-03-2021 which was received by this Commission on 10-05-2021 for not getting the information sought by him from the PIO / O/o the Excise Circle Inspector, Banswada Mandal, Nizamabad District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: 02-02-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application annexed.

1. గీత పారిశ్రామిక సహకార సంఘం, భైంసా పట్టణం. ఈ సంఘం లోని గీత కార్మికులకు ఏ అధికారి సమక్షంలో కల్లు గీత వృత్తి పరిక్ష (ట్యాపింగ్ టెస్ట్) జరిగినది. అది ఏ సంవత్సరంలో జరిగినది. వాటి యొక్క సమాచారం కురియు CD/ DVD/ Memory Card ఏదైనా కాపీ ఇవ్వాలను

Stating that the PIO has not furnished the required information even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, the Complaint was taken on file and Notices issued to both the parties for hearing on 08-04-2022 at 12:00 P.M.

The case is called on 06-07-2022. The complainant is present and filed his affidavit stating that the PIO has not furnished the information. The PIO / Sri S. Ramesh Kumar, Prohibition and Excise Inspector, Bhainsa Mandal, Nirmal District is present and filed his affidavit stating that reply was given to the appellant vide letter No: 02/RTI/2021/Bhainsa dated: 20-02-2021 informing that the information sought relates to 37 years old, hence the same is not available and could not be furnished. The PIO filed copy of the letter before the Commission.

Heard both the parties and perused the material papers available on record and observed that the appellant filed 6(1) dated: 02-02-2021 seeking certain information relating to Toddy Geeta Co Operative Society, Bhainsa Mandal tapping test and in which year the test was conducted and who is the inspecting Officer and the PIO vide letter dated: 20-02-2021 informed that the information sought relates to 37 years old, hence the same is not available and could not be furnished.

The PIO submitted that he has brought the available information to the Commission.

The Commission directs the PIO to furnish the available information to the appellant within One (1) Week from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the appeal is closed.
