Order

Sri Mohd. Zakaullah Shareef, Hyderabad has filed a Complaint dated: 11-05-2022 which was received by this Commission on 12-05-2022 for not getting the information sought by him from the PIO – I / O/o the Tahsildar, Yelmati Nagar, Balapur Mandal, Ranga Reddy District & PIO – II / O/o the Tahsildar, Road No. 13, C-Type, Gayatri Nagar, Saroornagar Mandal, Ranga Reddy District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: 12-07-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application annexed.

I am the purchaser of land in Survey No. 267/ (A) and (AA), situated at Municipally village, Balapur Mandal, R.R. Dist and I request you to kindly furnish the attested copies of the following documents early : -

1. Proceedings Order vide File No. B/2471/06 dated 13-06-2006 pertaining to Patta No. 1008, along with all the attachments.
2. Copies of the documents based on which your office has implemented the above order vide File No. B/2471/06 dated 13-06-2006.
3. Notices issued to Ghulam Nabi in 2005 and their actual implementation.
4. Notices issued to the legal heirs of Sri. Kanha Bahadur and their actual implementation in the year 2004 – 2005.

Stating that the PIO has not furnished the required information even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, the Complaint was taken on file and Notices issued to both the parties for hearing on 14-07-2022 at 10.30 A.M.

The case is called on 14-07-2022. The appellant is present and filed his affidavit stating that the PIO has not furnished the information. The PIO – I / Sri K. Subramanyam, Deputy Tahsildar, Balapur Mandal, Ranga Reddy District is present and filed his affidavit stating that reply was given to the appellant vide letter No: RTI/163/2021 dated: 20-07-2021 and letter No: RTI/166/2021 dated: 03-08-2021.

The PIO – II / Sri Avinash Kumar Rai, Deputy Tahsildar, Saroornagar Mandal, Ranga Reddy District is present and filed his affidavit stating that reply was given to the appellant vide letter No: RTI/70/2021 dated: 24-08-2021.

Heard both the parties and perused the material papers available on record. The PIO furnished copy of the information to the appellant before the Commission.

Since the information is furnished, the appeal is closed.
