Order

Sri K. Venkataiah, Hyderabad has filed a Complaint dated: 11-01-2022 which was received by this Commission on 12-01-2022 for not getting the information sought by him from the PIO / O/o the Deputy Commissioner, Khairtabad, Circle-17, Hyderabad.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: 06-12-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application annexed.

SUB : APPLICATION UNDER SECTION 6 OF THE R.T.I. ACT 2005

I, K. Venkataiah R/o Flat No 203, Prithvi Complex, 4-70/2, Habsiguda, Street No. 8, Hyderabad, 500 007 do hereby file this application under Section 6 of the Right to Information Act, 2005 requesting for the following information.

As per building permission rules how many floors permission is granted to build a residential house in 240 square yards plot when the road facing the plot is 10 feet and also the setbacks on all the four sides to be followed in Padmavathi Nagar Colony, Khairatabad, Hyderabad -4.

Stating that the PIO has not furnished the required information even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, the Complaint was taken on file and Notices issued to both the parties for hearing on 18-08-2022 at 12.00 P.M.

The case is called on 18-08-2022. The complainant is absent. The PIO / Sri T. L. Ramesh Kumar, Assistant City Planner, O/o the Deputy Commissioner, GHMC Khairtabad, Circle – 17, Hyderabad is present and filed his affidavit stating that reply was given to the complainant vide letter No: 08/RTI/ACP/17/KZ/GHMC/2022 dated: 16-07-2022 and filed copy of the letter before the Commission.

Heard the PIO and perused the material papers available on record. The Commission is of the view that the PIO has furnished the information to the complainant.

Since the information is furnished, the complaint is closed.
