Order

Sri K. Madhu, Nirmal District has filed 2nd appeal dated: 10-01-2022 which was received by this Commission on 12-01-2022 for not getting the information sought by him from the PIO / O/o the Tahsildar, Laxmanchanda Mandal, Nirmal District and 1st Appellate Authority / O/o the Revenue Divisional Officer, Nirmal Division, Nirmal District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 02-03-2020 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

- ① - ఈ క్రింది తెలిపిన చర్ఖాస్తుదారు అయిన నాకు లక్ష్మణచాందా మఠకలంబా, న్యూకంబెక్ గ్రామ రెవెన్యూ శివారు యెడలి నాస్థల వ్యవసాయ ఖామియైన సర్వేనం. 92/అ విస్తీర్ణం : 2.28½ ను సంబంధించిన పట్టామూర్తికి దిద్దినటువంటి Form-11 (58/2009)ను సర్టిఫైడ్ కాపీ ఇవ్వగలరు.
- ② నాయెడలి ఈ వ్యవసాయ ఖామి (92/అ - 2.28½ నం.బి) వారసత్వంగా పొందినందువల్ల, దీనికి సంబంధించి కేవలం గల ఫారం-17 యెడలి సర్టిఫైడ్ కాపీ ఇవ్వగలరు.

పైన తెలిపిన రెండు అంశాలకు సంబంధించిన (Form-11, Form-17) రిజిస్ట్రార్లు అందుచేతులు తెలియజేయాలి వాటికి గల కారణాల తెలిపి, ఇవర మోర్-కాపీలు పంపించాలి. ఏ అంశం వచ్చినా కేవలం వాటికి సంబంధించిన ఛార్జీలు చెల్లించాలి తెలిపగలరు.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 05-06-2020 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal was taken on file and Notices issued to both the parties for hearing on 25-08-2022 at 12.00 P.M.

The case is called on 25-08-2022. The appellant is present and filed his affidavit stating that the PIO has not furnished the information. The PIO / Sri V. Gangadhar, Deputy Tahsildar, Laxmanchanda Mandal, Nirmal District is present and filed his affidavit stating that Form – 17 register is not traceable in their office.

Heard both the parties and perused the material papers available on record. The Commission took a serious view against the PIO for not furnishing the information to the complainant within the stipulated period of 30 days as per Section 7(1) of the RTI Act 2005. The Commission warns the PIO not to repeat such lapses in future and strictly adhere to the provisions of the RTI Act 2005.

The Commission directs the PIO to give a specific point wise reply to the appellant within Two (2) Weeks from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the appeal is closed.
