## Order

Sri Inumula Satyanarayan, Peddapalli District has filed 2<sup>nd</sup> appeal dated: 15-05-2022 which was received by this Commission on 17-05-2022 for not getting the information sought by him from the PIO / O/o the District Manager, Telangana State Civil Supplies Corporation Limited, Peddapalli District and 1<sup>st</sup> Appellate Authority / O/o the District Manager, Telangana State Civil Supplies Corporation Limited, Peddapalli District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 17-02-2022 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

- ② మంత్రి M.L.S. శాసనసభ సభ్యులకు సంబంధించి F.P. కేసులు, సభ్యుల పాపాలకు MDM కేసుల రవాణా మరియు F.P. కేసులకు సంబంధించి M.L.S. శాసనసభ్యులకు గెజిట్ చేయడం రవాణా జరిగిన 1-12-2021 మరియు విజ్ఞాపన 17వ రోజు వరకు ఉండాలి (17-2-2022) కొరత ఉంటుంది, స్టాక్ శాసనసభ కేసులకు ఉంటుంది (కేసులు కొరత)
- ③ 1-12-2021 మరియు 17-02-2022 వరకు గుజిరా 3 నెలలు పునరాధిష్టించడం స్టాక్-II రవాణా వాహనం ఉంటుంది, స్టాక్ నిల్వ కొరత, గెజిట్ చేయడం ని.ప. కేసులు కొరత ఉంటుంది (ని.ప. కేసులు) ఉంటుంది, ని.ప. కేసులు కొరత ఉంటుంది, ని.ప. కేసులు కొరత ఉంటుంది.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1<sup>st</sup> appeal dated: 22-03-2022 before the 1<sup>st</sup> Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1<sup>st</sup> Appellate Authority even after 30 days of filing his 1<sup>st</sup> appeal, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to take action against the PIO and 1<sup>st</sup> Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2<sup>nd</sup> appeal was taken on file and Notices issued to both the parties for hearing on 01-09-2022 at 10.30 A.M.

The case is called on 01-09-2022. The appellant is absent. The APIO / Sri S. Narasimha, Assistant Grade – I is present and filed affidavit of the PIO / Sri T. Venkatesh, District Manager (I/c), Telangana State Civil Supplies Corporation Ltd., Peddapalli District stating that reply was given to the appellant vide letter Rc. No: P.Admn/37/PDPL/RTI/2017 dated: 16-03-2022, 16-04-2022 and 13-05-2022 requesting to pay Rs. 800/- for point No: 1 & 2 and for point No: 3 the appellant was requested to approach the PIO / O/o the Telangana State Civil Supplies Corporation Ltd., Somajiguda, Hyderabad and filed copy of the same before the Commission.

Heard the PIO and perused the material papers available on record.

The Commission directs the PIO to furnish the information to the complainant only after paying the requisite fee as prescribed under RTI Act 2005.

In view of the above, the appeal is closed.
