Order

Sri Mohd Ashraf, Sirpur-Kagaznagar has filed 2nd appeal dated: 09-05-2022 which was received by this Commission on 17-05-2022 for not getting the information sought by him from the PIO / O/o the Commissioner & Director of School Education, Saifabad, Hyderabad and 1st Appellate Authority / O/o the Commissioner & Director of School Education, Saifabad, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 16-02-2022 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

ACB Trap Candidate మరియు District Collector, KB Asifabad గారు illegal activities చేస్తున్నారని అని surrender చేస్తే మరల Focal Post ఇవ్వడానికి గల కారణాలను ఇవ్వగలరు
4. Additional Secretary to Govt T.S గారి మేమో.నెం.5052/Ser.1/A1/2019-1, తేది.19-07-2019 పై DSC కార్యాలయం వారు చేపట్టిన చర్యల ప్రతులను Note File with Rule Position ను ఇవ్వగలరు
5. జిల్లా పరిపాలనాధికారి, K B Asifabad గారి లేఖ నెం.A1/571/2019 & లేఖ నెం.A1/569/2019, తేది.12-07-2019 ప్రకారం District Education Officer, KB Asifabad పై DSC కార్యాలయం లో సమర్పించిన నివేదిక ఆధారంగా వారు చేపట్టిన చర్యల ప్రతులను Note File with Rule Position ను ఇవ్వగలరు
6. జిల్లా పరిపాలనాధికారి, K B Asifabad గారి లేఖ నెం.H/633/2019, తేది.03-08-2019 ప్రకారం District Education Officer, KB Asifabad పై DSC కార్యాలయం లో సమర్పించిన నివేదిక ఆధారంగా వారు చేపట్టిన చర్యల ప్రతులను Note File with Rule Position ను ఇవ్వగలరు

and more few points.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 19-03-2022 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal was taken on file and Notices issued to both the parties for hearing on 26-09-2022 at 10.30 A.M.

The case is called on 26-09-2022. The appellant is absent. The APIO / Sri P. L. Kiran, Senior Assistant, O/o the Commissioner and Director of School Education, Saidabad, Hyderabad is present and orally submitted that reply was given to the appellant number of times, but the appellant is repeatedly seeking the same or similar information again and again.

Heard the APIO and perused the material papers available on record. The Commission took a serious view against the PIO for not furnishing the information to the complainant within the stipulated period of 30 days as per Section 7(1) of the RTI Act 2005. The Commission warns the PIO not to repeat such lapses in future and strictly adhere to the provisions of the RTI Act 2005.

The Commission directs the PIO to give specific point wise reply to the appellant within One (1) Week from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the appeal is closed.
