Order

Sri Kusnapelli Rajeshwar, Komarambheem Asifabad District has filed 2nd appeal dated: 18-05-2022 which was received by this Commission on 20-05-2022 for not getting the information sought by him from the PIO / O/o the Assistant Director, Survey and Land Records, Komarambheem Asifabad District and 1st Appellate Authority / O/o the District Collector, Asifabad Collectorate, Komarambheem Asifabad District

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 25-03-2022 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 29-04-2022 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal was taken on file and Notices issued to both the parties for hearing on 15-09-2022 at 12.00 P.M.

The case is called on 15-09-2022. The appellant is absent. Sri D. Parmeshwar, Computer Draftsman, Grade – I is present and filed affidavit of the PIO / Sri D. Someshwar, Inspector of Survey, Survey & Land Records, Komaram Bheem Asifabad District stating that reply was given to the appellant vide letter Rc. No: RTI/94/2022 dated: 17-5-2022 and filed copy of the same before the Commission.

Heard the PIO and perused the material papers available on record. The representative of the PIO stated that the Sarandi Village is having total Survey No: 112 only and the appellant is seeking 115/30, hence the said information could not be furnished.

In view of the above, the appeal is closed.
