## **Order**

Sri Mohd. Fareduddin, Hyderabad has filed a Complaint dated: 21-05-2022 which was received by this Commission on 23-05-2022 for not getting the information sought by him from the PIO / O/o the District Educational Officer, Nampally, Hyderabad.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: 12-04-2020 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application annexed.

1. Please furnish the list of 14 schools which are produced Bogus/Fabricated ETR's.
2. Please furnish the copy of letter Lr No: 2397/A7/PTO/2017 dt: 25:04:18.
3. Please furnish the copy of proceeding RCNo: 846/TS1/2015 Dt:16/10/2018 director of school education.
4. Furnish the attested copies of Present issued ETR's by DEO Hyderabad as per the orders of the commissioner and director of school education which are produced bogus/fabricated ETR's in past.
5. Furnish the attested copies of proposals submission from 14 school's correspondent's as per the order of director of school education vide proceeding RCNo: 846/TS1/2015 Dt:16/10/2018 such schools are regularized.

Stating that the PIO has not furnished the required information even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act.

In view of the above, the Complaint was taken on file and Notices issued to both the parties for hearing on 26-09-2022 at 10.30 A.M.

The case is called on 26-09-2022. The complainant is absent. The PIO / Sri B. Srinivas Reddy, Assistant Director, O/o the District Educational Officer, Nampally, Hyderabad is present and filed his affidavit stating that reply was given to the complainant vide letter No: 071/RTI/C1/2022 dated: 24-09-2022 informing that the information falls under 8(1)(h) of the RTI Act 2005, hence the same could not be furnished. The PIO filed copy of the letter before the Commission.

Heard the PIO and perused the material papers available on record. The Commission took a serious view against the PIO for not furnishing the information to the complainant within the stipulated period of 30 days as per Section 7(1) of the RTI Act 2005. The Commission warns the PIO not to repeat such lapses in future and strictly adhere to the provisions of the RTI Act 2005.

The Commission directs the PIO to give a specific reply to the complainant duly attesting within One (1) Week from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the complaint is closed.
