Order

Sri Pallela Devaraju, Karimnagar District has filed 2nd appeal dated: 18-05-2022 which was received by this Commission on 24-05-2022 for not getting the information sought by him from the PIO / Chief Administrative Officer, O/o the Prl. District Judge's Court, Karimnagar District and 1st Appellate Authority / O/o the Registrar General, High Court for the State of Telangana, Madina, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 18-02-2022 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

1) CC NO- 834/2021, FIR NO-69/2021, Register NO-619/2021

మొదల అగ్రాఫీ అని విచారణ చేస్తున్నట్లు సంబంధించి వివరాల
అందించాలి, వివరాల అందుకని దానిని ప్రాధాన్యతగా పూర్తిచేసి,
మరలకు ప్రతి ఫైలు తగిన అనుకూల సమయం తెలియజేయాలి.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 21-03-2022 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal was taken on file and Notices issued to both the parties for hearing on 16-09-2022 at 10.30 A.M.

The case is called on 16-09-2022. The appellant is absent. Sri B. Radha Krishna authorized representative of the PIO / Sri Laxmikant, Chief Administrative Officer, O/o the Prl. District & Sessions Judge's Court, Karimnagar District is present and filed his affidavit stating that reply was given to the appellant vide letter Dis. No: 129/R.T.I. Appl. No.06/2022/ADM/DCK dated: 23-02-2022 and filed copies of the same before the Commission.

Sri G. Naresh is present representing Sri A. Kranthi Kumar Reddy, Standing Counsel for O/o the First Appellate Authority-cum-Registrar General, High Court for the State of Telangana, Hyderabad and filed affidavit stating that vide appeal No: 20 of 2022 dated: 16-06-2022 dismissed the appeal confirming the order passed by the PIO.

Perused the material papers available on record.

Upholding the reply of the PIO and the First Appellate Authority, the appeal is closed.
