Order

Sri P. Shiva, Nirmal District has filed 2nd appeal dated: 05-11-2021 which was received by this Commission on 07-12-2021 for not getting the information sought by him from the PIO / O/o the Municipal Commissioner, Nirmal Municipality, Nirmal District and 1st Appellate Authority / O/o the Municipal Commissioner, Nirmal Municipality, Nirmal District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 05-11-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

తమరితో మనవి చేయునది ఏమనగా మీరు నాకు అందజేసిన లేఖ నం. A1/123/2021, తేదీ: 22.09.2021 నాకు RTI చట్టం క్రింద నేను అడిగిన పూర్తి వివరములు నాకు తెలియ పరచలేదు. కనుక నా యొక్క దరఖాస్తును పరిశీలించి RTI చట్టం క్రింద పూర్తి వివరములు ఇవ్వగలరని ప్రార్థన.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 07-12-2021 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal was taken on file and Notices issued to both the parties for hearing on 25-08-2022 at 12.00 P.M.

The case is called on 25-08-2022. The appellant is present and filed his affidavit stating that the PIO has furnished part information. The APIO / Sri T. Gangadhar, Revenue Officer O/o the Municipal Commissioner, Nirmal Municipality, Nirmal District is present and filed his affidavit stating that reply was given to the appellant vide letter No: A1/123/2021 dated: 22-09-2021 and again on 19-08-2022. The APIO filed copy of the information furnished to the appellant before the Commission.

Heard both the parties and perused the material papers available on record.

The Commission directs the PIO to give a specific point wise reply informing the present status to the appellant within One (1) Week from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the appeal is closed.
