## Order

Sri P. Karunakar, Nalgonda District has filed 2<sup>nd</sup> appeal dated: 07-06-2021 which was received by this Commission on 09-06-2021 for not getting the information sought by him from the PIO / O/o the Tahsildar, Chityal Mandal, Nalgonda District and 1<sup>st</sup> Appellate Authority / O/o the Revenue Divisional Officer, Nalgonda Division, Nalgonda District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 23-03-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

పేర్లో క్షాత్ర తెచ్చుంలి. ఈ విషయమి కింది సమాచారం ఇవ్వగలదు  
1) ఇట్టి పూజల ఎవరి పేరుమీదకి, ఎప్పుడో నుండి, ఏ ఏకల స్వతా (రిజిస్ట్రేషన్)  
పాల యిటో) బిల్లులడిగ్ అఖల పూజగంగా తెలుగులదు.  
2) ఇట్టి పూజలడిగ్ అమరికల్లయం స్వతా బిలి-చెయబడి సులంబి  
పెయిల కాపీలు( నల్లబొప్పి, పదనా, 18, 20, 22, అమిటిమింట్ బిల్లుల యి  
ప్రకారం ఇవ్వగలదు.  
3) వాసలలు డిగ్ సమాచారం ఇవ్వకుండా, నోటిఫికేషన్లు ఇటెమింట్  
పూజల పట్ల మార్కెట్ అమరికల్లయం స్వతా చెయవచ్చు? ఈ పట్ల కిట్టి  
కాంగ్రెస్ అధికారుల వివరాల వారి అధికార పరిధిని అఖల పూజగంగా ఇవ్వగలదు

Stating that the appellant did not receive the information from the PIO, the appellant filed 1<sup>st</sup> appeal dated: 24-04-2021 before the 1<sup>st</sup> Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1<sup>st</sup> Appellate Authority even after 30 days of filing his 1<sup>st</sup> appeal, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to take action against the PIO and 1<sup>st</sup> Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2<sup>nd</sup> appeal was taken on file and Notices issued to both the parties for hearing on 07-07-2022 at 10.30 A.M.

The case is called on 07-07-2022. The appellant is absent. The PIO / Sri V. Ragya Nayak, Deputy Tahsildar, Chityal Mandal, Nalgonda District is present and filed his affidavit stating that vide letter No: D/322/2021 dated: 09-04-2021 the appellant was called for inspection of records and furnished the available information on 12-04-2021 to the appellant by hand and filed copies of the same before the Commission.

Heard the PIO and perused the material papers available on record and observed that the appellant through his 2<sup>nd</sup> appeal dated: 07-06-2021 and his letter dated: 12-04-2021 stated that the PIO has not given reply for point No: 3 and has not furnished the complete information.

The Commission directs the PIO to give a specific reply for point No: 3 and furnish the information once again to the appellant within One (1) Week from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the appeal is closed.
