## **Order**

Smt. N. Laxmamma, Nalgonda District has filed 2<sup>nd</sup> appeal dated: 30-05-2022 which was received by this Commission on 30-05-2022 for not getting the information sought by her from the PIO / O/o the Revenue Divisional Officer, Devarakonda Division, Nalgonda District and 1<sup>st</sup> Appellate Authority / O/o the District Collector, Nalgonda Collectorate, Nalgonda District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 24-03-2022 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in her application:

గాజీనగర్ గ్రామ శివారులోని మా తండ్రి బోడ సాయిలు @ సాయస్సు గారి పేరున గల వ్యవసాయ భూమి సర్వేనెంబర్లు 90,92,93,94,95,98,102 లలో భూమి కలదు.

- 1) ఇట్టి భూములకు నాలా పర్మిషన్ ఇచ్చినారా, ఇవ్వలేదా పూర్తి సమాచారం తెలుపగలరు.
- 2) ఈ సర్వేనెంబర్లకు ఏ సంవత్సరంలో ఏ తేదినాడు నాలా పర్మిషన్ ఇచ్చినారు తెలుపగలరు.
- 3) ఈ సర్వేనెంబర్లలో ఎవరి పేరు మీది నుండి ఎవరి పేరున నాలా పర్మిషన్ ఇచ్చారు తెలుపగలరు. నాకు ఇచ్చిన సమాచారానికి అయ్యే ఖర్చులను నేనే భరిస్తాను.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1<sup>st</sup> appeal dated: 20-04-2022 before the 1<sup>st</sup> Appellate Authority requesting him to furnish the information sought by her u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1<sup>st</sup> Appellate Authority even after 30 days of filing her 1<sup>st</sup> appeal, she preferred this 2<sup>nd</sup> appeal before this Commission requesting to take action against the PIO and 1<sup>st</sup> Appellate Authority for not furnishing information sought by her and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2<sup>nd</sup> appeal was taken on file and Notices issued to both the parties for hearing on 19-08-2022 at 10.30 A.M.

The case is called on 19-08-2022. The appellant is present and filed his affidavit stating that the PIO has not furnished the information.

Sri D. Sunil Kumar, Senior Assistant is present on behalf of the PIO / Sri K.M.V. Jagannadha Rao, District Revenue Officer (FAC), Collectorate Nalgonda, Nalgonda District and filed his affidavit stating that vide letter No: A8/2436/2022 dated: 18-03-2022 and vide letter No: A5/3218/2022 dated: 27-04-2022 the application was transferred to the PIO / O/o the Tahsildar, Kondamallepalli Mandal, Nalgonda District and the PIO / O/o the Revenue Divisional Officer, Devarkonda Division, Nalgonda District with a request to furnish the information to the appellant. The representative of the PIO filed copy of the letters before the Commission.

Sri Md. Sirajoddin, Senior Assistant is present and filed affidavit of Sri K. Gopiram, Revenue Divisional Officer, Devarkonda Division, Nalgonda District stating that reply was given to the appellant vide letter No: C/915/2022 dated: 21-05-2022 that there are no NALA permissions given in the Survey numbers as sought in the 6(1) application. The representative of the PIO filed copy of the letter before the Commission.

Heard both the parties and perused the material papers available on record.

The Commission directs the PIOs to conduct a detailed enquiry and furnish the information to the appellant once again duly attesting within Two (2) Weeks from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the appeal is closed.
