Order

Sri U. Vimal Babu, Hyderabad has filed 2nd appeal dated: 01-06-2022 which was received by this Commission on 03-06-2022 for not getting the information sought by him from the PIO / O/o the Ex-Officio Secretary, CAF & CS Department, IV-Floor, BRK Bhavan, Secretariat, Hyderabad and 1st Appellate Authority / O/o the CA & Civil Supplies Department, Secretariat, BRK Bhavan, IV Floor, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 25-02-2022 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

Kindly supply the copy of the entire file bearing number 1313/CS.I-LM/2019, including the run on note

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 16-03-2022 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal was taken on file and Notices issued to both the parties for hearing on 01-09-2022 at 10.30 A.M.

The case is called on 01-09-2022. The appellant is present and filed his affidavit stating that the PIO has not furnished the information. The PIO / Sri M. Surender Reddy, Assistant Secretary to Government, CAF &CS Department, BRKR Bhavan Secretariat, Hyderabad is present and filed his affidavit stating that reply was given to the appellant vide letter No: 383/CS.I-LM/2022 dated: 11-03-2022 informing that the information sought cannot be furnished as per Section 8(1)(h) of RTI Act 2005 hence rejected.

Heard both the parties and perused the material papers available on record.

The PIO stated that the action is still under process and is pending with the Controller of Legal Metrology, Hyderabad. The PIO furnished the available information to the appellant before the Commission.

In view of the above, the appeal is closed.
