Order

Dr. P. Rajender Kumar Naik, Hyderabad has filed 2nd appeal dated: 10-06-2021 which was received by this Commission on 22-06-2021 for not getting the information sought by him from the PIO / O/o the District Educational Officer, Nampally, Hyderabad and 1st Appellate Authority / O/o the Commissioner & Director of School Education, Saifabad, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 02-03-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

Provide following information:

1. How many application received from ST Community/Caste Admissions for the academic year 2021-2022 is LKG Bharatiya Vidya Bhavan School Jubilee Hills Hyderabad. Please provide information in below format

2. Please provide information how many ST candidates were selected in LKG Academic year of 2021-2022 through Lucky Draw provide information in below format.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 06-04-2021 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal was taken on file and Notices issued to both the parties for hearing on 06-07-2022 at 12:00 P.M.

The case is called on 06-07-2022. The appellant is present and filed his affidavit stating that the PIO has not furnished the information. The PIO / Sri G. Parmeshwar, Assistant Director, O/o the Commissioner and Director of School Education, Hyderabad is present and filed his affidavit stating that the appellant filed 6(1) dated: 12-03-2021 before the PIO / Principal, Bharatiya Vidya Bhavan's Atmakuri Rama Rao School, Jubilee Hills, Hyderabad requesting to furnish information on 5 points and filed 1st appeal dated: 14-04-2021 before the First Appellate Authority / O/o the Commissioner and Director of School Education, Hyderabad and vide letter No: 453/RTI/2021 dated: 30-06-2021 the application was forwarded to the PIO / O/o the District Educational Officer, Nampally, Hyderabad with a request to furnish the information to the appellant. The PIO filed copies of the same before the Commission.

The APIO / Sri Ch. Rajashekhar, Auditor Cum Superintendent, O/o the District Educational Officer, Nampally, Hyderabad is present and filed his affidavit stating that vide letter Rc. No: 607/RTI/C3/2021 dated: 24-01-2022 forwarded the application to the PIO / O/o the Deputy Inspector of Schools, Shaikpet Mandal, Hyderabad with a request to furnish the information to the appellant. The PIO filed copies of the same before the Commission.

The PIO / Sri B. Ramalingam, Head Master / Deputy Inspector of Schools, Shaikpet Mandal, Hyderabad is present and filed his affidavit stating that reply was given to the appellant vide letter No: 1059/SKPT/2022 dated: 11-02-2022 informing that Bharatiya Vidya Bhavan's Atmakuri Rama Rao School, Jubilee Hills, Hyderabad doesn't come under the purview of the PIO / Deputy Inspector of Schools, Shaikpet Mandal, Hyderabad and is functioning under Ranga Reddy District. The PIO filed copy of the same before the Commission.

Heard both the parties and perused the material papers available on records. The Commission is not satisfied with the reply of the PIO / Deputy Inspector of Schools, Shaikpet Mandal, Hyderabad and warns the PIO not to repeat such lapses in future and strictly adhere to the provisions of RTI Act 2005.

The Commission directs the PIO to furnish the available information to the appellant within Two (2) Weeks from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the appeal is closed.
