Order

Sri T. Sreedhar, Ranga Reddy District has filed 2nd appeal dated: 08-06-2022 which was received by this Commission on 08-06-2022 for not getting the information sought by him from the PIO / O/o the Commissioner & Director of School Education, Saifabad, Hyderabad and 1st Appellate Authority / O/o the Commissioner & Director of School Education, Saifabad, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 09-02-2022 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

1. Candidates for the post of School Assistant who appeared DSC Maths from Medak Village & Mandal from Medak District and their Hall Ticket Number with Rank and obtained Marks in the Year 2008 & 2012.

2. Bandari Saritha Goud B.Saritha, D/o.B.Pandari Goud, DOB: 08/07/1982 H.No.1-12-4/A/1, Jambikunta, Medak Village & Mandal, Medak District, Pin- 502110, who appeared DSC Maths from Medak Village & Mandal from Medak District, and her Hall Ticket Number with Rank and obtained Marks conducted DSC in the Year 2008 & 2012.

The PIO / O/o the Commissioner & Director of School Education, Saifabad, Hyderabad vide Lr. No. 446/A6/RTI/2022, dated. 21-03-2022 transferred an application U/s 6(3) of the RTI Act to O/o the District Educational Officer, Sangareddy District with a request to furnished the information to the appellant.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 25-03-2022 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal was taken on file and Notices issued to both the parties for hearing on 26-09-2022 at 10.30 A.M.

The case is called on 26-09-2022. The appellant is absent. The APIO / Sri P.L. Kiran, Senior Assistant, O/o the Commission & Director of School Education, Hyderabad is present and filed his affidavit stating that vide letter No: 75/RTI/2022 dated: 22-04-2022 the application was transferred u/s 6(3) of the RTI Act 2005 to the PIO / District Educational Officer, Medak, Hyderabad with the request to furnish the information to the appellant.

Sri J. Vinay Kumar, Junior Assistant is present and filed affidavit of the PIO / Smt. A. Vijaya, Assistant Director, O/o the District Educational Officer, Sanga Reddy District stating that the information was furnished to the appellant vide letter No: 1346/A5/RTI/2022 dated: 18-07-2022 and filed copy of the information before the Commission.

Perused the material papers available on record. The Commission is of the view that the PIO has furnished the information to the appellant.

Since the information is furnished, the appeal is closed.
