Order

Sri S.Q. Masood, Hyderabad has filed 2nd appeal dated: 17-01-2022 which was received by this Commission on 17-01-2022 for not getting the information sought by him from the PIO / O/o the Commissioner & Director Of School Education, Saifabad, Hyderabad and 1st Appellate Authority / O/o the Commissioner & Director Of School Education, Saifabad, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 03-11-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

- 1) This is the request to you please provide the copy of the G.O Rt No 37 dated: 21-03-2017 constituted committee to submit report for Regulation of Fee Structure in Private unaided schools and unaided sections of private aided schools and schools affiliated to different boards such as CBSE, ICSE, IB, Cambridge etc in the State.
- 2) The Chairman of the Committee has submitted its report to the Govt. on 30-12-2017. This is the request to you please provide the copy of the report submitted by the Chairman of the Committee.
- 3) The Govt. in March, 2018, extended the period of the committee for 3-months to submit information on certain items. This is the request to you please provide the copies of the Items on which government requested Chairman to submit information.
- 4) This is the request to you please provide the copy of the final report submitted by the Chairman and status of the report.
- 5) This is the request to you please provide the copies of representations / requests / suggestions made by the Political Parties, Private Schools Teachers Association, Parents Associations and general public to the Chairman of the Committee, during the course of meetings on the subject.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 07-12-2021 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal was taken on file and Notices issued to both the parties for hearing on 26-09-2022 at 10.30 A.M.

The case is called on 26-09-2022. The appellant is present and filed his affidavit stating that the PIO has not furnished the information. The APIO / Sri P. L. Kiran, Senior Assistant, O/o the Commissioner and Director of School Education, Saidabad, Hyderabad is present and filed his affidavit stating that reply was given to the appellant vide letter Rc. No: 1226/PS3/RTI/2021 dated: 23-12-2021 and filed copy of the same before the Commission.

Heard both the parties and perused the material papers available on record. The appellant stated that he is not in receipt of the information and the APIO furnished copy of the information to the appellant before the Commission under acknowledgement.

Since the information is furnished, the appeal is closed.
