## **Order**

Sri S.Q. Masood, Hyderabad has filed 2<sup>nd</sup> appeal dated: 17-01-2022 which was received by this Commission on 17-01-2022 for not getting the information sought by him from the PIO / O/o the Commissioner & Director Of School Education, Saifabad, Hyderabad and 1<sup>st</sup> Appellate Authority / O/o the Commissioner & Director Of School Education, Saifabad, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 03-11-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

*This is the request to you please provide digital / scanned copies of updated Rules, Regulations, Instructions, Manuals and Records for discharging functions under section 4(1)(b)(v) & (vi) of the RTI Act. (List of the documents attached for your reference).*

Stating that the appellant did not receive the information from the PIO, the appellant filed 1<sup>st</sup> appeal dated: 07-12-2021 before the 1<sup>st</sup> Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1<sup>st</sup> Appellate Authority even after 30 days of filing his 1<sup>st</sup> appeal, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to take action against the PIO and 1<sup>st</sup> Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2<sup>nd</sup> appeal was taken on file and Notices issued to both the parties for hearing on 26-09-2022 at 10.30 A.M.

The case is called on 26-09-2022. The appellant is present and filed his affidavit stating that the PIO has not furnished the information. The APIO / Sri P. L. Kiran, Senior Assistant, O/o the Commissioner and Director of School Education, Saidabad, Hyderabad is present and requested to give time to furnish the information.

Heard both the parties and perused the material papers available on record. The Commission took a serious view against the PIO for not furnishing the information to the complainant within the stipulated period of 30 days as per Section 7(1) of the RTI Act 2005. The Commission warns the PIO not to repeat such lapses in future and strictly adhere to the provisions of the RTI Act 2005.

The Commission directs the PIO to furnish the information to the appellant within One (1) Week from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the appeal is closed.
