Order

Sri Pentaparthi Prabhakar, Adilabad District has filed a Complaint dated: 22-03-2022 which was received by this Commission on 13-06-2022 for not getting the information sought by him from the PIO / O/o the District Collector, Adilabad Collectorate, Adilabad District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: 11-10-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application annexed.

Stating that the PIO has not furnished the required information even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, the Complaint was taken on file and Notices issued to both the parties for hearing on 15-09-2022 at 12.00 P.M.

The case is called on 15-09-2022. The complainant is present and filed his affidavit stating that the PIO has furnished part information. Ms. P. Soujanya, Typist, O/o the District Collector, Adilabad District is present and filed affidavit of the PIO / Sri R. Arvind Kumar, District Revenue Officer (I/c), Adilabad Collectorate, Adilabad District stating that vide letter No: A6/1/0260/2021 dated: 28-11-2021 the application was transferred u/s 6(3) of RTI Act 2005 to the PIO / Assistant Pension Officer (Pension), DRDA, Adilabad District with a request to furnish the information to the appellant and the PIO / Assistant Project Officer, DRDA(Accounts), Adilabad District vide File No: 2/RTI/2016 dated: 20-12-2021 informing that the information is furnished to the appellant and filed copy of the letter along with postal receipt before the Commission.

Heard both the parties and perused the material papers available on record.

The Commission directs the PIO / Assistant Project Officer, DRDA(Accounts), Adilabad District and the PIO / District Revenue Officer (I/c), Adilabad Collectorate, Adilabad District to look into the matter and furnish the information or give specific reply to the complainant duly attesting within One (1) Week from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

In view of the above, the complaint is closed.
