## Order

Sri Pentaparthi Prabhakar, Adilabad District has filed 2<sup>nd</sup> appeal dated: 13-06-2022 which was received by this Commission on 13-06-2022 for not getting the information sought by him from the PIO - I / O/o the Tahsildar, Jainad Mandal, Adilabad District, PIO - II / O/o the District Collector, Adilabad Collectorate, Adilabad District and 1<sup>st</sup> Appellate Authority / O/o the District Collector, Adilabad Collectorate, Adilabad District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 29-09-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

Stating that the appellant did not receive the information from the PIO, the appellant filed 1<sup>st</sup> appeal dated: 16-11-2021 before the 1<sup>st</sup> Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1<sup>st</sup> Appellate Authority even after 30 days of filing his 1<sup>st</sup> appeal, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to take action against the PIO and 1<sup>st</sup> Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2<sup>nd</sup> appeal was taken on file and Notices issued to both the parties for hearing on 15-09-2022 at 12.00 P.M.

The case is called on 15-09-2022. The appellant is present and filed his affidavit stating that the PIO has furnished part information. Ms. P. Soujanya, Typist, O/o the District Collector, Adilabad District is present and filed affidavit of the PIO - I / Sri R. Arvind Kumar, District Revenue Officer (I/c), Adilabad Collectorate, Adilabad District stating that vide letter No: A6/1/0220/2021 dated: 14-10-2021 the application was forwarded u/s 6(3) of the RTI Act 2005 to the PIO / O/o the Tahsildar, Jainad Mandal, Adilabad District with a request to furnish the information to the appellant. The representative of the PIO filed copy of the letter before the Commission.

The PIO - II / Smt, L. Rajeshwari, Deputy Tahsildar, Jainad Mandal, Adilabad District is present and filed her affidavit stating that reply was given to the appellant vide letter No: B/481/2021 dated: 27-01-2022 and on receipt of the Commission Notice dated: 30-08-2022 reply was once again given to the appellant vide letter No: B/388/2022 dated: 13-09-2022 by hand and filed copies of the same before the Commission.

Heard both the parties and perused the material papers available on record. The appellant stated that the PIO has not furnished the complete information. The PIO submitted that the balance information would be available with the PIO / Assistant Director, Survey & Land Records, Adilabad District.

The Commission directs the PIO / Assistant Director, Survey & Land Records, Adilabad District to furnish the balance information or give specific reply to the appellant duly attesting within Ten (10) days from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the appeal is closed.
