## Order

Sri D. Satyanarayana, Nalgonda District has filed 2<sup>nd</sup> appeal dated: 13-06-2022 which was received by this Commission on 13-06-2022 for not getting the information sought by him from the PIO / Assistant Secretary to Government, School Education Ser.II Department, Telangana Secretariat, BRKR Bhavan, Hyderabad and 1<sup>st</sup> Appellate Authority / Deputy Secretary to Government, School Education Department, BRKR Bhavan, IV Floor, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 26-03-2022 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

*I, D. Satyanarayana of Nalgonda, with reference to the Subject & the references cited, pertaining to the 1996-DSC & 1998-DSC, here by submitting application through the RTI Act to furnish the copies of Note Files No. 4762-1996-DSC and 9205-1998-DSC from 1st page to last recent pages up to 26<sup>th</sup> March 2022. And at the same time, Action taken Reports of copies on my representations regarding the 1996-DSC & 1998-DSC as per the Govt orders, Cd DSC reports & DEO, Nalgonda Reports on both the issues which still pending at the Dept. The number of applications being submitted to the Govt of Telangana, to consider the request for posting orders to the post of SGT- of both 96 & 98 DSCs from the 2014 to 2022 till today. No orders are given till today. Hence, I am requesting and submitting my application through RTIA, to furnish the comprehensive information what I desired. Note-file pages, orders, proceedings & memo copies all pertaining to 1996 & 1998 DSC matters. Under the Right to Information Act of 2005, with immediate effect in time and to be furnished the memo. no 1084/ser-11/A2/2022, dt 16-02-2022 also along with the above.*

Stating that the appellant did not receive the information from the PIO, the appellant filed 1<sup>st</sup> appeal dated: 26-04-2022 before the 1<sup>st</sup> Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1<sup>st</sup> Appellate Authority even after 30 days of filing his 1<sup>st</sup> appeal, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to take action against the PIO and 1<sup>st</sup> Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2<sup>nd</sup> appeal was taken on file and Notices issued to both the parties for hearing on 26-09-2022 at 10.30 A.M.

The case is called on 26-09-2022. The appellant is present and filed his affidavit stating that the PIO has not furnished the information. The PIO / Smt. K. Krishna Veni, Assistant Secretary to Government, School Education Ser-II Department, Telangana State Secretariat, BRKR Bhavan, Hyderabad is present and filed her affidavit stating that reply was given to the appellant vide letter No: 5164/Ser-II/A2/2022 dated: 27-04-2022 informing that the file is under circulation. The PIO filed copy of the letter along with postal receipt before the Commission.

Heard both the parties and perused the material papers available on record.

The Commission directs the PIO to inform the present status of the application as on date to the appellant duly attesting within Fifteen (15) days from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the appeal is closed.
