**Order**

Sri N. Gopal Reddy, Hyderabad has filed a Complaint dated: 16-07-2021 which was received by this Commission on 17-07-2021 for not getting the information sought by him from the PIO / O/o the Tahsildar, Nakrekal Village & Mandal, Nalgonda District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: 01-04-2019 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application annexed.

Handwritten text in Telugu script, likely a copy of the application or complaint details. It includes dates like 01/04/2019 and 28-12-2018, and mentions 'RTI Act, 2005'. The text is partially obscured by a watermark.

Stating that the PIO has not furnished the required information even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, the Complaint was taken on file and Notices issued to both the parties for hearing on 07-07-2022 at 10.30 A.M.

The case is called on 07-07-2022. The complainant is present and filed his affidavit stating that the PIO has furnished the information. The PIO / Smt. R. Vijaya, Deputy Tahsildar, Nakrekal Mandal, Nalgonda District is present and filed her affidavit stating that part information was furnished to the complainant vide letter No: B/1356/2019 dated: 09-02-2019 and complete information was furnished to the complainant vide letter No: B/12922/2021 dated: 29-11-2021. The PIO filed copies of the same before the Commission.

Heard both the parties and perused the material papers available on records and observed that the complainant filed 6(1) dated: 01-04-2019 seeking information on 3 points and as per the submission of the PIO the information was furnished on 09-02-2019 and 29-11-2021 which is contrary and misleading.

The Commission directs to issue **Show Cause Notice** to the present PIO / Smt. R. Vijaya, Deputy Tahsildar, Nakrekal Mandal, Nalgonda District and the then PIO / Sri P. Srinivas, Deputy Tahsildar, Nakrekal Mandal, Nalgonda District for not furnishing the information to the complainant within the stipulated period of 30 days as per Section 7(1) of RTI Act 2005. The action on the **Show Cause Notice** will be dealt separately.

The Commission directs the present PIO to give point wise specific reply and furnish the information to the complainant within Two (2) Weeks from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the complaint is closed.
