## **Order**

Sri Silaram Thirupathi, Peddapalli District has filed a Complaint dated: 13-01-2022 which was received by this Commission on 18-01-2022 for not getting the information sought by him from the PIO / Secretary, District Legal Services Authority, Karimnagar District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: 18-11-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application annexed.

1. పీఎల్సీ నెం.210/2020 తేది:27-02-2021 రోజున అవార్డు అయిన అవార్డు(ఆర్డర్) కాపీలు అటెస్టేడ్ చేసి ఇవ్వగలరు.
2. పీఎల్సీ నెం.210/2020లో పిటిషనర్ వేసిన పిటిషన్ కాపీలు మరియు రెస్పాండెంట్స్ వేసిన కౌంటర్ కాపీ(జవాబు) ప్రతులు ఇవ్వగలరు.
3. పీఎల్సీ నెం.210/2020లో పిటిషనర్ మరియు రెస్పాండెంట్లు దాఖలు చేసి కోరుకు సంబంధించి దాక్యుమెంట్స్ ఇవ్వగలరు.
4. పీఎల్సీ నెం.210/2020లో పిటిషనర్ మరియు రెస్పాండెంట్లు వ్రాసుకున్న(చేసుకున్న) లెటర్స్ & కండీషన్స్ కాపీలు ఇవ్వగలరు.

Stating that the PIO has not furnished the required information even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, the Complaint was taken on file and Notices issued to both the parties for hearing on 16-09-2022 at 10.30 A.M.

The case is called on 16-09-2022. The complainant is present and filed his affidavit stating that the PIO has furnished part information. The PIO / Smt. T. Sujatha, Superintendent, O/o the Secretary, District Legal Services Authority, Karimnagar District is present and filed her affidavit stating that the information was furnished to the complainant vide letter Dis. No: 18/2022 dated: 12-01-2022 and the same was returned by the Postal Department with a noting "Unclaimed returned to sender". The PIO filed copies of the same along with the postal receipt before the Commission.

Heard both the parties and perused the material papers available on record. The complainant stated that he is not in receipt of the information, the PIO furnished copies of the same before the Commission under acknowledgement of the complainant.

Since the information is furnished, the complaint is closed.
