Sri K. Jitender Reddy, Rangareddy District has filed 2nd appeal dated: 28-07-2021 which was received by this Commission on 29-07-2021 for not getting the information sought by him from the PIO / O/o the Tahsildar, Mothkur Mandal, Nalgonda District and 1st Appellate Authority / O/o the Revenue Divisional Officer, Bhongir Division, Nalgonda District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 19-04-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: **Nil** before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act, 2005.

Stating that the appellant did not get the information from the PIO / $1^{\rm st}$ Appellate Authority even after 30 days of filing his $1^{\rm st}$ appeal, he preferred this $2^{\rm nd}$ appeal before this Commission requesting to take action against the PIO and $1^{\rm st}$ Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

The case is called on 07-07-2022. The appellant is present and filed his

Mothkur Mandal, Yadadri Bhuvanagiri District and filed his affidavit stating that

the information was furnished to the appellant vide letter No: C/386/2021 dated:

19-07-2021.

Sri D. Radha Krishna, Senior Assistant is present on behalf of the First

Appellate Authority / Sri M.V. Bhupal Reddy, Revenue Divisional Officer,

Bhuvanagiri Division, Yadadri Bhuvanagiri District and filed his affidavit stating

that vide letter No: E/1981/2020 dated: 29-04-2021 the application was

transferred u/s 6(3) of RTI Act 2005 with a direction to the PIO / O/o the

Tahsildar, Mothkur Mandal, Yadadri Bhuvanagiri District to furnish the

information to the appellant.

Heard both the parties and perused the material papers available on record.

The appellant stated that he is not in receipt of the said information and the PIO

furnished the information to the appellant before the Commission. The appellant

stated that the information furnished is incomplete.

The Commission gives a final opportunity to the appellant and directs the

PIO to allow the appellant for verification of records on a mutually fixed date and

time and furnish the required information to the appellant as sought by the

appellant through his 6(1) dated: 19-04-2021 through registered post with

acknowledgement due & to report compliance.

With the above direction, the appeal is closed.
