Sri Vollala Srinivas, Jagityal District has filed a Complaint dated: 18-7-2021 which was received by this Commission on 07-08-2021 for not getting the information sought by him from the PIO / O/o the Registrar Judicial, High Court for the State of Telangana, Hyderabad.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: 24-05-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application annexed.

Stating that the PIO has not furnished the required information even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, the Complaint was taken on file and Notices issued to both the parties for hearing on 02-06-2022 and 19-08-2022 at 12:00 P.M.

The case is called on 19-08-2022. The complainant is absent. The PIO / Sri V. Mohan Rao, Deputy Secretary to Government, Law Department, BRKR Bhavan, Hyderabad is present and filed his affidavit stating that reply was given to the complainant vide letter dated: 19-07-2021 that the information sought doesn't come under the definition of information under RTI Act 2005 and was returned. The PIO filed copy of the letter before the Commission.

Heard the PIO and perused the material papers available on record. The Commission upholds the reply of the PIO.

In view of the above, the complaint is closed.
