Order

Sri S. Srinivas Gandla, Karimnagar District has filed a Complaint dated: 20-03-2021 which was received by this Commission on 11-08-2021 for not getting the information sought by him from the PIO / O/o the Mandal Praja Development Officer, Ramadugu Mandal, Karimnagar District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: 28-02-2020 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application annexed.

1. THE RTI 4 1 B INFORMATION OF YOUR OFFICE PROVIDE.WITH EMPLOYEES IN VELICHALA2005-1 9 PERIOD.
 2. THE CITIZEN CHARTER OF YOU PROVIDE.
 3. THE ACTS RULES REGULATIONS CODES MANNUALS FOLLOWING IN OFFICIAL WORKS OF ALL YOUR EMPLOYEES PROVIDE.
 4. THE BENEFICIRIES LIST OF ALL YOUR PROVIDING TO PUBLIC PROVIDE IN RTI 4 1 B XII AND XIII FROM 2014-2019 IN YOUR OFFICE.
 5. THE DEFAULTERS LIST AND REGULAR PAYMENTERS OF BILLS OF FOLLOWING VILLAGES PROVIDE IN YOUR 4 1 B... A- VELICHALA B-RAMADUGU C-GUNDI D-GOPALRAOPET.
 6. THE CASES FILED WITH FINE PAID RECEIPTS AND CASE PAPERS SIGNED BY THE OWNERS OF H.NO2-62 AND 3-51 OF VELICHALA VILLAGE PROVIDE.
 7. THE ADDITIONAL CHARGES COLLECTED FROM THE CONSUMERS REFUNDING THEM IN THE CASES OF DOMESTIC USER PAID COMMERCIAL CHARGES.
 8. THE POWER DROP/INTERRUPTION LOG BOOK IN THE VILLAGE OF VELICHALA PROVIDE FOR THE PERIOD OF 2013 JAN TO 2013 JUNE PROVIDE.
 9. THE FULL CURRENT AND HALF CURRENT SUPPLIED IN THE VELICHAL A VILLAGE IN 2013 JAN TO 2013 JUNE WITH HOURS OF SUPPLIED DETAILS PROVIDE.
 10. THE FREE BOOKS CD DVDS MAGAZINES ON THE POWER CONSUMPTION ,SAFTY ETC ISSUES PROVIDE. Meter no. 1451, 1474 Connected in the name in velichala 2008 to 2020.
 11. ANY OTHER INFORMATION YOU HAD AND SELFLY GIVING TO PUBLIC PROVIDE FROM RTI ACT PASSED.
 12. THE GP BOREWELLS AND OPEN WELLS AND THE POWER SUPPLY AND INTERRUPTION TO THEM IN 2013 JAN TO 2013 JUNE WIT FULL/THREE PAZE CURRENT PROVIDE IN 4 1 B.
 13. THE CHARGES TO SERVICES YOU PROVIDING TO PUBLIC AND TIME PERIOD TO SOLVE THEM.
 14. THE CURRENT POLLS NAKSHA WITH THE POLL WISE ALLOTTED METERS IN VELICHALA PROVIDE. 2 LED Bulbs beneficiaries list provided in velichala 2015-2020.
 15. THE RTI I,II RECORDS AND 1ST 2ND APPEALS WITH ORDERS PROVIDE IN 2005-2019 PERIOD.
 16. THE INDIRAMMA METERS BENEFICIARS LIST PROVIDE FROM 2004-2019 IN VELICHALA.
- SEND ONLY REGD POST POSTAL OSS DEPT RESPONSIBLE.
- ENCLOSED : U/S 7[5] FEES EXEMPTION AND FREE SUPPLY OF INFORMATION TO BPL OLD GOVT ISSUED RATION CARD WITH RTI ISSUES.

Stating that the PIO has not furnished the required information even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, the Complaint was taken on file and Notices issued to both the parties for hearing on 22-07-2022 at 10.30 A.M.

The case is called on 22-07-2022. The complainant is absent. Sri B. Kiran, Junior Assistant is present and filed affidavit of the PIO / Sri B. Rajesh, O/o the MPDO, Ramadugu Mandal, Karimnagar District stating that they are not in receipt of the 6(1) application dated: 28-02-2020, hence could not furnish the information and on receipt of the Commission notice dated: 02-07-2022 vide letter No: A1/10/RTI/2022-14 dated: 12-07-2022 the application was transferred u/s 6(3) of RTI Act 2005 to the PIO / Assistant Engineer, O/o the *Northern Power Distribution Company of Telangana Limited*, Ramadugu Mandal, Karimnagar District with a request to furnish the information to the complainant.

Perused the material papers available on record and observed that the complainant filed 6(1) application dated: 28-02-2020 before the PIO / Assistant Engineer, O/o the *Northern Power Distribution Company of Telangana Limited*, Ramadugu Mandal, Karimnagar District seeking information on 20 points and by over sight notices were sent to the PIO / O/o the MPDO, Ramadugu Mandal, Karimnagar District.

In view of the above, the Commission directs the PIO / Assistant Engineer, O/o the *Northern Power Distribution Company of Telangana Limited*, Ramadugu Mandal, Karimnagar District to furnish the available and held information to the complainant within Two (2) Weeks from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the complaint is closed.
