Order

Sri S. Srinivas Gandla, Karimnagar District has filed a Complaint dated: 20-03-2021 which was received by this Commission on 10-08-2021 for not getting the information sought by him from the PIO / O/o the Mandal Praja Parishad, Ramadugu Mandal, Karimnagar District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: 05-07-2020 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application annexed.

Stating that the PIO has not furnished the required information even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, the Complaint was taken on file and Notices issued to both the parties for hearing on 22-07-2022 at 10.30 A.M.

The case is called on 22-07-2022. The complainant is absent. Sri B. Kiran, Junior Assistant is present and filed affidavit of the PIO / Sri B. Rajesh, O/o the MPDO, Ramadugu Mandal, Karimnagar District stating that they are not in receipt of the 6(1) application dated: 05-07-2020, hence could not furnish the information and on receipt of the Commission notice dated: 02-07-2022 vide letter No: A1/10/RTI/2022-13 dated: 12-07-2022 the application was transferred u/s 6(3) of RTI Act 2005 to the PIO / Assistant Engineer, O/o the *Northern Power Distribution Company of Telangana Limited*, Ramadugu Mandal, Karimnagar District with a request to furnish the information to the complainant.

Perused the material papers available on record and observed that the complainant filed 6(1) application dated: 05-07-2020 before the PIO / O/o the MPDO, Ramadugu Mandal, Karimnagar District seeking information on 21 points relating to Electrical Department and the PIO forwarded the application to the concerned PIO on 12-07-2022. The Commission is also of the view that the complainant has not filed any postal evidence of filing the 6(1) application before the PIO.

In view of the above, the Commission directs the PIO / O/o the MPDO, Ramadugu Mandal, Karimnagar District and the PIO / Assistant Engineer, O/o the *Northern Power Distribution Company of Telangana Limited*, Ramadugu Mandal, Karimnagar District to furnish the available and held information only to the complainant within Two (2) Weeks from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the complaint is closed.
