## **Order**

Sri Shaik Zafar, Nizamabad District has filed a Complaint dated: 16-01-2022 which was received by this Commission on 20-01-2022 for not getting the information sought by him from the PIO / O/o the Municipal Commissioner, Nizamabad Municipal Corporation, Nizamabad District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: 09-12-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application annexed.

Details of the {137} words of information desired herein. (within 500 words limits prescribed under Rule 3 of RTI Rules 2012]

1. Information about the name of the Municipal Shopping Complex being build over the Bakra Market place in Ahmedi Bazar, Nizamabad.
2. Copy of the Map of that complex.
3. Information about quantum of funds released for building that

The PIO / O/o the Municipal Commissioner, Nizamabad Municipal Corporation, Nizamabad District vide Lr. No. ME/PIO-281/2021, dated. 22-12-2021 transferred an application U/s 6(3) of the RTI Act to O/o the Executive Engineer, R&B Division, Nizamabad District with a request to furnish the information to the Complainant.

Stating that the PIO has not furnished the required information even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, the Complaint was taken on file and Notices issued to both the parties for hearing on 01-09-2022 at 10.30 A.M.

The case is called on 01-09-2022. The complainant is absent, but filed his affidavit stating that the PIO has furnished the information. The PIO / Sri M. A. Quadeer, Superintendent, O/o the Executive Engineer, R&B Division, Nizamabad District is present and filed his affidavit stating that the information was furnished to the appellant vide letter No: Supdt/NZBD/RTI Act 2005/2021-22/1798 dated: 17-02-2022 and filed copy of same before the Commission.

Heard the PIO and perused the material papers available on record.

Since the complainant himself accepted that he in receipt of the information, the complaint is closed.
