## **Order**

Sri Malgireddy Srinivas Reddy, Hyderabad has filed 2<sup>nd</sup> appeal dated: 09-08-2021 which was received by this Commission on 11-08-2021 for not getting the information sought by him from the PIO / O/o the Tahsildar, Pedda Adisharpally Mandal, Nalgonda District and 1<sup>st</sup> Appellate Authority / O/o the Revenue Divisional Officer, Devarakonda Mandal, Nalgonda District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 13-01-2020 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

- 1) Keshamnenipally village P.A.Pallymandalsy number 15/5/1 online pahani print shows on the date 12/01/2020 on the name of MuliKoteshwaramma, please issue a copy of sy number 15/5/1 digitalization proposal sheet by VRO, MRI.
- 2) Keshamnenipally village sy number 15/5/1 amendment done on the date 06/01/2020, please issue a certified copy of amendment.
- 3) Keshamnenipally village P.A.Pally mandal sy number 15/5/1 mutation proceedings number MUT/28/25/01029/2019, please issue a certified copy of mutation proceedings.  
The application fee 10/- I have paid through 43F 988096 postal order under RTI act 2005 for this please issue a receipt of acknowledgement with signature date and seal of your office.

In view of the above please serve the certified copies of above specific matter at an early date.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1<sup>st</sup> appeal dated: 28-02-2020 before the 1<sup>st</sup> Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1<sup>st</sup> Appellate Authority even after 30 days of filing his 1<sup>st</sup> appeal, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to take action against the PIO and 1<sup>st</sup> Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2<sup>nd</sup> appeal was taken on file and Notices issued to both the parties for hearing on 07-07-2022 at 10.30 A.M.

The case is called on 07-07-2022. The appellant is present and filed his affidavit stating that the PIO has not furnished the information. The PIO / Ms. O. Sridevi, Deputy Tahsildar, Adisherlapally Mandal, Nalgonda District is present and filed her affidavit stating that the records were handed over to ACB in 2020 and the detailed report was submitted to the District Collector, Nalgonda District, hence the said information could not be furnished and at present the available information is brought to the Commission.

Heard both the parties and perused the material papers available on record.

The Commission directs the PIO / O/o the District Collector, Nalgonda District and the PIO / Deputy Tahsildar, Adisherlapally Mandal, Nalgonda District to give a specific reply or furnish the information to the appellant within Two (2) Weeks from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the appeal is closed.
