Order

Sri Devulapally Laxminarayana, Mancherial District has filed 2nd appeal dated: 13-08-2021 which was received by this Commission on 16-08-2021 for not getting the information sought by him from the PIO / O/o the District Collector, Mancherial Collectorate, Mancherial District and 1st Appellate Authority / O/o the District Collector, Mancherial Collectorate, Mancherial District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 13-02-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

- 1) మంచెర్లాల జిల్లా సమాచార హక్కు చట్టం సమన్వయ కమిటీ నియామకం కారణం ది. 07-01-2021 నాడు ఖోరు ఫర్ జిల్లా పో. మంచెర్లాల జిల్లా స్థానిక ద్వారా మంచెర్లాల జిల్లా కలెక్టరు (జిల్లా పరిపాలనా అధికారి) తాళికి సమన్వయ ఫరఖాస్తా రోజు వారి ప్రకారం నివేదిక ఇచ్చానని.
- 2) మంచెర్లాల జిల్లా పరిధిలోని ప్రభుత్వ స్థానాలు ఎన్ని స్థానాలు లకు 2016 నుంచి వచ్చిన సమాచార ఫరఖాస్తాలు ఎన్ని సమాచారం ఎన్ని ఫరఖాస్తాలకు అందించారు.
- 3) మంచెర్లాల జిల్లా విస్తృత అప్రెటెనండ్ సమాచార హక్కు చట్టం అవగాహన కారణం వచ్చిన ప్రభుత్వ స్థానాలు ఎన్ని, అవగాహన సకస్థాలు ఎన్ని నిర్వహించారు మండలాల వారీగా ప్రాంత వివరాలు తెలుసుకోవడా ఇచ్చానని.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 18-03-2021 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal was taken on file and Notices issued to both the parties for hearing on 21-07-2022 at 12.00 P.M.

The case is called on 21-07-2022. Sri J. Kalyan Chakravarthy representing the appellant is present and stated that the PIO has not furnished the information. Smt. M. Sherisha, Section Assistant is present on behalf of the PIO / Sri Madhusudan Naik, Additional Collector / District Revenue Officer (FAC), Mancherial District and filed affidavit stating that reply was given to the appellant by hand vide letter Rc. No: A2/RTI/4559-1/2021 dated: 28-08-2021 and filed copy of the same before the Commission.

Heard both the parties and perused the material papers available on record.

The Commission directs the PIO to furnish the information once again to the appellant duly attesting within One (1) Week from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the appeal is closed.
